VILLAGE OF RAYMOND ORDINANCE NO. 52

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF RAYMOND.

BE IT ORDAINED BY THE VILLAGE OF RAYMOND AS FOLLOWS:

SECTION 1 - A Petition has been filed with the Village Council of the Village of Raymond, Minnesota, by the owners of the following described real estate asking that such land be included within the Village of Raymond, Minnesota, as follows:

Property located in the County of Kandiyohi, State of Minnesota, more particularly described as follows: That part of the SE 1/4 of the NE 1/4, Section 19, Township 118, Range 36, described by metes and bounds as follows: Commencing at the Southeast corner of DeJong's Addition to the Village of Raymond, Minnesota, according to the recorded plat thereof on file at the office of the Register of Deeds in and for said County; thence North along the East line of said DeJong's Addition a distance of 390 feet to a point which is also the Northwest corner of DeJong's Second Addition and which point is the place of beginning; thence continuing North on the East line of said DeJong's Addition a distance of 360 feet to a point; thence East and parallel with the South line of the SE 1/4 of the NE 1/4 of said Section 19 a distance of 360 feet to a point; thence South and parallel with the East line of said DeJong's Addition a distance of 360 feet to a point which is the Northeast corner of said DeJong's Second Addition; thence West and parallel with the South line of the Southeast Quarter of the Northeast Quarter of said Section 19 a distance of 360 feet to the place of beginning.

SECTION 2 - The land embraced in the foregoing description does not exceed 200 acres in area.

SECTION 3 - Copies of the said Petition were on the day of January, 1966, filed with the Minnesota Municipal Commission, the Town Board of Edwards Township, the County Board of the County of Kandiyohi, State of Minnesota and although more than thirty days have elapsed since the time of said filing no written objection to the proposed annexation has been made to the Minnesota Municipal Commission or the Village of Raymond.

SECTION 4 - The Village Council makes the following determination, to-wit:

1) That the annexation will be to the best interests of the Village of Raymond, Minnesota and the territory affected.

2) That the territory described herein abuts upon and is adjacent to the Village of Raymond, Minnesota and is so conditioned as properly to be subject to the Government of said Village.

SECTION 5 - Therefore, the Village of Raymond, Minnesota hereby ordains and declares that the property hereinbefore described be, and the same hereby is annexed to, and included in the Village of Raymond, Minnesota.

SECTION 6 - This ordinance shall be final and shall take effect and shall be in full force from and after filing a certified copy thereof with the Minnesota Municipal Commission, the County Auditor of Kandiyohi County and the Secretary of State of the State of Minnesota.
