Board Minutes

On December 2, 1915, the board passed a resolution to conduct a lecture tour, and moving picture exhibitions in Iowa, Illinois and Indiana.

November 13, 1915. Henry O'Neill of Crookston, having furnished satisfactory proofs that he had expended \$650.00 in making various coin and other exhibits at the Panama-Pacific Exposition at San Francisco, was ordered paid \$325.00, as one half of expenses incurred by him.

November 15, 1915. Motion made carried that two moving picture tours be conducted during the winter throughout Iowa, Illinois and Indiana.

Frank H. Eddy and John B. Deets were engaged as lecturers.

Salaries

Section 3949, Statute 1913 provides the board shall fix the salaries and define the duties of all employees.


At various times the board has fixed salaries as follows:-

This seems to cover the regular office force for the fiscal year, with the exception of Francis Halligan, who rendered services for about three months at \$60.00 per month.
