CHAPTER 19.05

AN ORDINANCE ANNEXING CERTAIN ADJACENT AND ABUTTING REAL ESTATE TO THE  
VILLAGE OF BUFFALO

ANNEXATION OF REAL ESTATE  
SECTION 19.05

Upon the petition of all of the owners of the following described real estate, presented to the Village Council, at its regular meeting on the 10<sup>th</sup> day of November, 1965; that on the 12th day of November, 1965, copies of the Petition for Annexation were filed with the following: The Municipal Commission, 51. State Office Building, St. Paul, Minnesota 55101; Mr. Albert Schimmel, Buffalo Township Clerk, Buffalo, Minnesota; Mr. David S. Douglas, County Auditor, Wright County Court House, Buffalo, Minnesota; that no objections have been filed herein by any of the above, or any other person; that all the provisions of Section 41.403, sub-division 2 of Minnesota Statutes Annotated, and other provisions applicable thereto, have been complied with and that it appears to be the best interest of the Village of Buffalo and the territory hereinafter described that the said territory be annexed to the Village of Buffalo, the Village Council of Buffalo do ordain:

Section 1. That the following described unplatted real estate, not exceeding 200 acres, and adjacent to and abutting upon the said Village of Buffalo, in the County of Wright and State of Minnesota, described as follows, to-wit:

All of the Northeast Quarter of the Southeast Quarter of Section 31, in Township 120, of Range 25, excepting that part thereof already in the Village of Buffalo; also the North 4 rods of the Southeast Quarter of the Southeast Quarter of Section 31, in Township 120, of Range 25

be and the same is hereby annexed to the Village of Buffalo and shall become a part thereof as effectually as if it had been originally a part thereof.

Section 2. That the annexation of the territory described above shall be determined final upon filing of a copy of the ordinance with the Municipal Commission of the State of Minnesota, the Secretary of State of the State of Minnesota, and the County Auditor of Wright County, Minnesota and the Town Clerk of the Township of Buffalo, Wright County, Minnesota.
