Dear Mr. Keldsen:

In reference to your letter of February 23, 1966 regarding the omitted portion of a street as outlined on our map to be included in the annexation ordinance, we have checked this out and have now included this portion of the street in our annexation ordinance No. 1781.

ORDINANCE NO. 1181

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ALBERT LEA TO TERRITORY CONTAINING UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 500 ACRES IN AREA ADJACENT WITHIN THE CITY LIMITS

Introduced by Councilman Walter H. Hanger

WHEREAS, a certain petition dated January 19, 1956, requesting annexation of the territory hereinafter described was duly presented to the Council on the 19th day of January 1956; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 5.46 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all owners and

WHEREAS, no objections to the annexation have been received from the Board of Supervisors, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition came upon the authority city limits.

THE COUNCIL OF THE CITY OF ALBERT LEA, HEREBY ORDAINS:

Sec. 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected (2) that the territory described herein came upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Sec. 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

DESCRIPTION OF BLOCKS 20 & 21 SHERRILL HEIGHTS

Beginning 2192.42 feet North and 321.37 feet East of the South & Corner of Section 5, Township 102 North, Range 21 West; thence Southwesterly 8.92 feet on a curve to the left, with a central angle of  $1^{\circ}19.6'$  and a radius of 305.00 feet, to the Northeast Corner of lot 10, Block 19 of the recorded plat of Blocks 17, 18 and 19 Sherrill Heights; thence North  $75^{\circ}12'$  West, 172.22 feet, along the northerly line of said lot 10; thence North  $15^{\circ}40'$  West 315.50 feet; thence North  $24^{\circ}49'$  West, 122.00 feet; thence North  $19^{\circ}28'$  West, 61.52 feet; thence North  $25^{\circ}10'$  West, 110.00 feet; thence North  $5^{\circ}09'$  West, 65.00 feet; thence South  $62^{\circ}29'$  East, 149.00 feet; thence North  $89^{\circ}34'$  East, 321.35 feet; thence South  $31^{\circ}27'$  East, 10.00 feet; thence South  $33^{\circ}31'$  East, 303.72 feet; thence South  $27^{\circ}23'$  East, 111.16 feet; thence South  $11^{\circ}59'$  East, 41.13 feet; thence South  $20^{\circ}23'$  East, 37.50 feet; thence South  $34^{\circ}04'$  East, 100.51 feet; thence South  $18^{\circ}38'$  West, 122.50 feet; thence South  $1^{\circ}03'$  West, 57.15 feet; thence North  $60^{\circ}37'$  West, 165.81 feet, along the Northeastly line of Lots 1 and 2, Block 19 of the recorded plat of Blocks 17, 18 and 19 Sherrill Heights, thence Southwesterly 73.65 feet on a curve to the right, with a central angle of  $10^{\circ}41'$  and a radius of 394.00 feet to the end point of said curve and along the Northeastly line of said lot 1 thence Northeastly 60.00 feet to the point of beginning; Being part of the Northeast Quarter of the Southeast Quarter and the Southwest Quarter of the Northeast Quarter of Section 5, Township 102 North, Range 21 West, and containing 5.46 acres. A110  
All that part of Block 20 lying between above described tract and the south line of lot 1 Block 19 enclosed northerly.

Sec. 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Sec. 4. That the above property is hereby zoned as R-1 Residential.

Sec. 5. Effective Date. The ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.


