ORDINANCE NO. 432

AN ORDINANCE ANNEXING PROPERTY TO THE CITY OF WHITE
BEAR LAKE, MINNESOTA

WHEREAS, all of the property owners of the real estate hereinafter described, have petitioned the City Council of the City of White Bear Lake, Minnesota, to have the following described real estate annexed to the City of White Bear Lake, Minnesota; and

WHEREAS, the City Council deems it advisable and in the public interest that said property be so annexed.

NOW THEREFORE, the City Council of the City of White Bear Lake, Minnesota, does ordain as follows:

Section 1 That the following described real estate situated in Ramsey County, Minnesota:

Part of the SW1/4 of NE 1/4 north and east of following line beginning on east line of and 680.75 ft from NE corner of said 1/4 1/4 thence south 39° 57' - W 87.49 ft thence curve to right to radius 270.4 ft from 205.53 ft thence north 46° 30' west 32.62 ft thence curve to left radius 337.77 ft for 76.51 ft thence north 23° 30' east 3.51 ft thence curve to left radius 314.28 ft for 113.27 ft thence north 0° 20' 10 sec. west 405.34 ft to north line of said 1/4 1/4 subject to easements in Sec 36, T 30, R22.

be and the same is hereby annexed to the City of White Bear Lake, Minnesota, and the said property is hereby declared to be an addition to said City.

Section 2 Upon the effective date of this Ordinance such property shall become a part of said City as effectively and as if it has been originally a part thereof.

Section 3 This Ordinance shall take effect and be in force from and after its passage and publication, and the City Manager of the City of White Bear Lake, Minnesota, is directed to cause a certified copy of this Ordinance to be recorded and filed in the office of the County Auditor, Ramsey County, Minnesota, the office of the Secretary of State for the State of Minnesota, and the Minnesota Municipal Commission.


