

Municipal Order J-28

RESOLUTION FOR ANNEXATION BY THE CITY OF ANOKA

WHEREAS, a petition has been received from the owners of all of the property herein requesting the detachment of the land in the City of Coon Rapids, County of Anoka, described as:

The Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of Section Six (6), Township Thirty-one (31), Range Twenty four (24), (now platted as part of Second Revision Auditor's Subdivision Number 9)

and

The Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of Section Six (6), Township Thirty-one (31), Range Twenty four (24), (now platted as part of Second Revision Auditor's Subdivision Number 9), all in the County of Anoka, State of Minnesota;

and

WHEREAS, said lands are contiguous to the City of Anoka; and

WHEREAS, said petition and the petitioners state as the reason for the request for detachment that the City of Coon Rapids cannot feasibly service said lands with municipal, sewer and water and other municipal services; and

WHEREAS, the City of Coon Rapids, by a resolution passed by its Council on February 15, 1966, has declared it to be the intention of the City Council of the City of Coon Rapids that the lands described above be detached from the City of Coon Rapids; and

NOW THEREFORE BE IT RESOLVED, by the Council of the City of Anoka as follows:

1. It is hereby declared to be the intention of the City of Anoka that the following described land now in the City of Coon Rapids, County of Anoka, be annexed to the City of Anoka, Anoka County, Minnesota:

The Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of Section Six (6), Township Thirty-one (31), Range Twenty-four (24), (now platted as part of Second Revision Auditor's Subdivision Number 9)

and

The Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of Section Six (6), Township Thirty-one (31), Range Twenty-four (24), (now platted as part of Second Revision Auditor's Subdivision Number 9), all in the County of Anoka, State of Minnesota.

2. The City Manager of the City of Anoka is hereby directed to transmit a certified copy of this resolution to the governing body of the City of Coon Rapids and another certified copy to the Municipal Commission of the State of Minnesota, all as provided in M.S.A. Section 414.06.
3. The Minnesota Municipal Commission is hereby requested, upon receipt of a certified copy of this resolution and a certified copy of a concurrent resolution by the City of Coon Rapids detaching the real estate described herein, to make and enter its Order detaching the said real estate from the City of Coon Rapids and annexing the same to the City of Anoka.

ORDER

The City of Coon Rapids has, by resolution of the City Council dated the 15th day of February, 1966, petitioned for the detachment of certain property and the City of Anoka has concurrently, by resolution of the City Council at a regular meeting held on March 7th, 1966, petitioned to annex the same territory, pursuant to Minnesota Statutes 414.06.

The territory involved consists of:

The NE $\frac{1}{4}$  of the NE $\frac{1}{4}$  of Section 6, Township 31, Range 24, (now platted as part of 2nd Revision Auditor's Subdivision Number 9)

and

The SE $\frac{1}{4}$  of the NE $\frac{1}{4}$  of Section 6, Township 31, Range 24, now platted as part of 2nd Revision Auditor's Subdivision Number 9, all in the County of Anoka, State of Minnesota

All the requirements of the statutes having been met,

IT IS ORDERED: That the above described property be and the same hereby is detached from the City of Coon Rapids and annexed to the City of Anoka, the same as if it had originally been a part thereof.
