ORDER

The above entitled matter was heard by the Court in Regular Term at the Court House at Ortonville, Minnesota, on the 28th of March, 1966. Gordon C. Moosbrugger, Special Assistant Attorney General, appeared for the petitioner and there were no other appearances.

Upon the testimony, records, and proceedings herein, and the files of the Clerk of District Court in the Matter of the Petition for the Organization of a Drainage and Flood Control District, etc., to be known as the Minnesota Valley Drainage and Flood Control District, the Court makes the following

FINDINGS OF FACT

I

The Minnesota Valley Drainage and Flood Control District was established by order of the District Court, S. A. Flaherty, Judge, 16th Judicial District, and Richard T. Daly, Judge, 12th Judicial District, on the 28th day of September, 1917, with its principle place of business at Ortonville, Minnesota, and contained land in the Counties of Big Stone, Lac qui Parle, Chippewa, Swift, Stevens, and Traverse;

II

No work has been performed during the five-year period immediately prior to the 23rd of April, 1955, nor for many years prior thereto, and no application has been made by such district.
