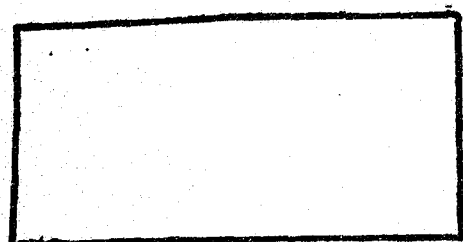



WHEREAS it now appears likely that there will be a special session of the Minnesota legislature before the expiration of the term in which the vacancy exists;


NOW, THEREFORE, I, KARL F. ROLVAAG, AS GOVERNOR OF THE STATE OF MINNESOTA, acting under the authority and direction of Section 17 of Article IV of the Minnesota Constitution and the statutes in such case made and provided, do hereby direct that said vacancy be filled at a special election to be held in said district on Tuesday the 10th day of May, 1966, and that candidates for said office be nominated at a special primary election to be held in said district on Tuesday, the 26th day of April, 1966; that affidavits of candidacy for nomination at

said primary may be filed on and between the 18th day of April, 1966 and the 23rd day of April, 5:00 P.M., 1966, both dates inclusive; that notices of said primary election and the said election thereafter be given, posted, and published as prescribed by law; and that the nomination and election of candidates and the conduct of said elections be had, and all things pertaining thereto be done, as provided in Minnesota Statutes, Sections 203.44 to 203.56, and other applicable provisions of law.
