ORDINANCE NO. 61

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF CHANHASSEN. TO INCLUDE CERTAIN PLATTED AND UNPLATTED LANDS NOT EXCEEDING 200 ACRES.

SECTION 1.

A petition has been filed with the governing body of the Villag of Chanhassen, Minnesota, by all of the owners in number of the following described real estate to have such land included with in the Village of Chanhassen, Minnesota:

(1) Owners Earl F. McAllister and Martha E. McAllister, husband and wife - All that part of Lot 16, Auditor's Subdivision No. 2 Carver County, Minnesota, being located in Section 12, Township 116 North, Range 23 West, described as follows: Commencing at the Southeast corner of said Lot 16; thence West along the South line of said Lot 16, 189.4 feet to a point; thence in a Norther. direction along a line drawn from said last described point to a point in the Northerly line of Lot 14, Auditor's Subdivision No. 2, distant 112.52 feet Westerly from the Northeast corner of said Lot 14, a distance of 225 feet; thence in an Easterly direction parallel to the South line of said Lot 16, 189.4 feet. more or less, to a point on the East line of Lot 16; thence Soul along the East line of Lot 16 to the point of beginning, accord. ing to the plat or map thereof on file or of record in the Offic of the Register of Deeds, Carver County, Minnesota.

The Village Council hereby determines (1) that the annexation will be to the best interest of the Village of Chanhasson, Minnesota and of the territory affecteds whit the territory described herein abuts upon the Village and is so, conditioned as to properly be subjected to Village Government.

Section 4. Therefor, the Village of Chanhassen, Minnesota hereby ordains and declares that the property herein-before described be and the same is hereby annexed to, and included in the Village of Chanhassen, Minnesota, as effectually as if it had originally been a part thereof.

SECTION 5. This Ordinance shall be final and shall take effect and be in force from and after filling a certified copy thereof with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State, and from and after its passage and publication.
