ORDINANCE NO. 181

An Ordinance annexing a part of the West Half of the Southwest Quarter of the Northwest Quarter of the Northeast Quarter (W 1/2 of SW 1/4 of NW 1/4 of NE 1/4) of Section Twenty-nine (29), Township Thirty (30), Range Twenty-one (21).

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DO ORDAIN AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by the owners of the land hereinafter described, in Washington County, Minnesota, containing less than two hundred acres, abutting on the Easterly side of the Village of Mahtomedi, requesting the annexation of said land to said Village, said Petition having been duly filed with the Clerk of said Village, and it appearing that such annexation will be to the best interests of the Village and of the territory affected, the Village boundaries of the Village of Mahtomedi are hereby extended to include said land described as follows:

All that part of the West Half of the Southwest Quarter of the Northwest Quarter of the Northeast Quarter (W 1/2 of SW 1/4 of NW 1/4 of NE 1/4) of Section Twentynine (29), Township Thirty (30), Range Twenty-one (21), described as follows:

Commencing at a ppint located in the West line of above described parcel 258.4 feet South of the Northwest corner of said parcel, thence Easterly on a bearing of N89°07' along the Wildwood School fence a distance of 172 feet; thence South a distance of 85 feet; thence Westerly on a bearing of S89°07' a distance of 172 feet; thence North along the West line a distance of 85 feet to the point of beginning.

and that said territory is hereby made a part of the Village of Mahtomedi as effectually as if the same had originally been a part of said Village.

Section 2. This Ordinance shall take effect and be in force upon the filing of a certified copy thereof with the County Auditor of Washington County and the Secretary of State of the State of Minnesota and with the Minnesota Municipal Commission and from and after its publication.
