Councilman Hubert offered the following resolution and passed the
caption.

Be It Ordained by the Village Council of the Village of Pine City that the
following ordinance, to be known as Ordinance No. 15, be enacted.

WHEREAS, the Pine City Development Corporation is the owner of the hereinafter
described premises, has petitioned the Village Council to annex the property described
as follows:

That part of the Southwest Quarter of Northeast Quarter (SW $\frac{1}{4}$ of NE $\frac{1}{4}$)
of Section Twenty eight (28), Township Thirty nine (39), Range Twenty
One (21), that lies east of the N.P.R.R. described as follows:
Beginning at a point on the North line of said SW $\frac{1}{4}$ of NE $\frac{1}{4}$ of said
section that is 755.9 feet east of the Northwest corner of the SW $\frac{1}{4}$ of
NE $\frac{1}{4}$ of said section, this point being 200 feet east of the Easterly
R.O.W. line of the N.P.R.R.; thence South parallel to the R.O.W.
line of the N.P.R.R. a distance of 333.0 feet, thence west parallel
with the North line of the said SW $\frac{1}{4}$ of NE $\frac{1}{4}$ a distance of 200.0 feet
to the Easterly R.O.W. line of the N.P.R.R.; thence westerly along
the West R.O.W. of the N.P.R.R. to the South line of SW $\frac{1}{4}$ of NE $\frac{1}{4}$ of
section 28, Township 39, Range 21; thence east along the South line
a distance of 428.2 feet to a point that is 950.2 feet east of the
Southwest corner of said forty; thence north parallel to the West
line of said forty to a point that is 417.0 feet south of the North
line; thence east parallel to the North line of said forty to the
East line of said forty; thence north to the Northwest corner of said
forty; thence west to the point of beginning. Less Highway R.O.W.

WHEREAS, notice of said petition was served upon the Village Clerk of the
Village of Pine City, the Town Board of the Township of Peaseport, the County
Board of the County of Pine and the Legislative Commission of the State of Minnesota,
and,

WHEREAS, more than thirty (30) days have elapsed since the notice was served
upon the above boards, and no written objection having been filed, and,

WHEREAS, the land does not exceed 200 acres, and,

WHEREAS, the Village of Pine City deems that it be to the best interests of
the Village of Pine City to annex said territory.

Be It Herely Ordained that the Village of Pine City, pursuant to Section 41b.03,
Subdivision 2, Minnesota Statutes Annotated does hereby annex said hereinafore
described premises to the Village of Pine City.
