

Councilman Haycock offered the following resolution and moved its adoption.

Be It Ordained by the Village Council of the Village of Pine City that the following ordinance, be known as Ordinance No. 15A be ordained.

WHEREAS, the Phillips Petroleum Company is the owner of the hereinafter described premises, has petitioned the Village Council to annex the property described as follows:

A parcel of land in the Southeast one quarter (SE $\frac{1}{4}$) of the Southeast one quarter (SE $\frac{1}{4}$) of Section 32, Township 39 North, Range 21 West, of the 4th Principal Meridian, more particularly described as follows to-wit: Beginning at the Northeast corner of said SE $\frac{1}{4}$ of SE $\frac{1}{4}$, thence South 1322.76' to the Southeast corner thereof, thence West on the South line of said SE $\frac{1}{4}$ of SE $\frac{1}{4}$ a distance of 581.62' to the East R.O.W. line of Interstate Highway No. 35, thence Northerly on said R.O.W. line to a point on the North line of said SE $\frac{1}{4}$ of SE $\frac{1}{4}$ which is 438.18' West of the point of beginning, thence East 438.18' to the point of beginning. Containing 16.15 acres, and that part of the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of said Section, Town and Range described as follows, to-wit: Beginning at the Southeast corner of said NE $\frac{1}{4}$ of SE $\frac{1}{4}$, thence West on the South line thereof a distance of 438.18' to the Highway R.O.W. line, thence in a Northerly and Easterly direction on said R.O.W. line to the East line of said NE $\frac{1}{4}$ of SE $\frac{1}{4}$, said point being 0.81' North of the point of beginning, thence South 8.81' to the point of beginning, containing 0.75 acre.

WHEREAS, notice of said petition was served upon the Village Clerk of the Village of Pine City, the Town Board of the Township of Pine City, the County Board of the County of Pine and the Municipal Commission of the State of Minnesota, and,

WHEREAS, more than thirty (30) days have elapsed since the notice was served upon the above boards, and no written objection having been filed, and,

WHEREAS, the land does not exceed 200 acres, and,

WHEREAS, the Village of Pine City deems that it be to the best interest of the Village of Pine City to annex said territory.

Be It Hereby Ordained that the Village of Pine City, pursuant to Section 414.03, Subdivision 2, Minnesota Statutes Annotated does hereby annex said hereinbefore described premises to the Village of Pine City.
