

Councilman Haycock offered the following resolution and moved its adoption.

Be it Ordained by the Village Council of the Village of Pine City that the following ordinance, to be known as Ordinance No. 15 B be ordained.

WHEREAS, the Gulf Oil Corporation is the owner of the hereinafter described premises, has petitioned the Village Council to annex the property described as follows:

A tract of land in the Northeast Quarter of the Southeast Quarter (NE $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section Thirty two (32), Township Thirty nine (39), North, Range Twenty one (21) West of the 4th Principal Meridian, Pine County, Minnesota, more particularly described as follows, to-wit: Commencing at the Northeast corner of said NE $\frac{1}{4}$ of SE $\frac{1}{4}$, thence South on the East line thereof a distance of 553.36 feet to the point of beginning of the tract to be herein described, said point being on the centerline of Public Road, thence deflecting to the right an angle of 59°39' a distance of 500 feet, more or less, to the East R.O.W. line of the approach ramp to Inter-state Highway No. 35, thence in a Southerly and Easterly direction on the R.O.W. line of said Ramp and the approach from the U.S.T.H. No. 61, a distance of 500 feet, more or less, to the East line of said NE $\frac{1}{4}$ of SE $\frac{1}{4}$, thence North 593.49 feet to the point of beginning. Containing 3.64 acres, more or less, subject to flowage and highway easements.

WHEREAS, notice of said petition was served upon the Village Clerk of the Village of Pine City, the Township Board of Pine City, the County Board of the County of Pine and the Municipal Commission of the State of Minnesota, and,

WHEREAS, more than thirty (30) days have elapsed since the notice was served upon the above boards, and, no written objection having been filed, and,

WHEREAS, the land does not exceed 200 acres, and

WHEREAS, the Village of Pine City deems that it be to the best interest of the Village of Pine City to annex said territory.

Be It Hereby Ordained that the Village of Pine City, pursuant to Section 414.03, Subdivision 2, Minnesota Statutes Annotated does hereby annex said hereinbefore described premises to the Village of Pine City.

Councilman Olson seconded the resolution.
