FINDINGS OF FACT,
CONCLUSIONS OF LAW,
ORDER

A petition having been filed with the Minnesota Water Resources Board on August 17, 1965, seeking to establish the boundaries of the High Island Watershed District, pursuant to the provisions of Minnesota Laws of 1955, Chapter 799, as amended;

And the Board on December 17, 1965, having ordered that a hearing be held on said petition on the 27th day of January 1966, at 10:00 A.M. in the Community Hall, Arlington, Minnesota, and the Board having held said hearing pursuant to its order; and, Mr. Frank Murray, Deputy, Attorney General's office, Mr. Erling M. Weiberg, Administrative Secretary of the Board, and Mr. Russell Younggren, Board member, appearing with the Board's referee, Mr. Alvin Payne; and Mr. Donald Hunter, attorney, having appeared for the managers of the High Island Watershed District;

And the Board having heard testimony and evidence offered on behalf of the petitioners and by other persons at the hearing, and having duly considered the same and its files and records in the proceedings now makes the following FINDINGS OF FACT, CONCLUSIONS OF LAW, ORDER.

FINDINGS OF FACT

I. The High Island Watershed District was established by order of the Minnesota Water Resources Board dated June 14, 1957, and therein did define a boundary by specific townships, ranges, and sections and a watershed divide line as shown on the map described as Petitioners' Exhibit A, dated July 19, 1954.

II. That the High Island Watershed District territory lies in parts of Sibley, McLeod, and Renville Counties; that a petition, including a map, executed by the Sibley County Board of Commissioners, the McLeod County Board of Commissioners, and the Board of Managers of the High Island Watershed District, was filed with the Minnesota Water Resources Board. Proofs of Service substantiate the receipt of a copy of the petition by the Commissioner of Conservation, the Director of the Division of Waters, and the respective County Auditors of Sibley, McLeod, and Renville Counties, all pursuant to law;

III. The petition was found sufficient by the Board and a hearing was ordered to be held at 10:00 A.M. January 27, 1966, in the Community Hall, Arlington, Minnesota;

IV. The Director of the Division of Waters examined the petition and filed his report with the Board; which report was received in evidence at the hearing. A few suggested changes to the petitioner's proposed boundary was offered by the Director, in his report and he recommended that the boundary be in accordance with the petition and his suggestions.

V. Subsequent to the filing of the said petition, the managers of the High Island Watershed District reviewed their initial proposed boundary, and as a result of such examination, did amend their petition at the hearing.

VI. Of the following described land there was service by publication in a legal newspaper in Sibley, McLeod, and Renville Counties, and in addition, service by mail was made on persons whose property appearing in the Notice of Hearing, was not listed in the petition filed with the Board on August 17, 1965. In determining the revised boundary of the High Island Watershed District the Board considered the inclusion or exclusion of parts or all of the following lands:

VIII. The Minnesota Water Resources Board has jurisdiction over the matter of determining the boundary line of the High Island Watershed District and the authority to define said boundary;

X. That the said lands are contiguous and can be feasibly administered by the Managers of the established district;
