

ORDINANCE NO. 385

AN ORDINANCE DESIGNATING THE CORPORATE LIMITS OF THE CITY OF WORTHINGTON, MINNESOTA, TO INCLUDE CERTAIN UNPLATTED LANDS.

The City Council of the City of Worthington Do Ordain:

Section 1. A petition has been filed with the City Council of the City of Worthington, Minnesota, in which the City Engineer certified that the following described lands are completely surrounded by land within the corporate limits of the City of Worthington in which case said property may be annexed to the City pursuant to Minnesota Statutes 114.03, Subdivision 2,

That part of the Southwest Quarter (SW_{1/4}) of the Southwest Quarter (SW_{1/4}) of Section 13, Township 102 North, Range 40 West, in the County of Nobles described as follows: Commencing at the intersection of the west line of Burlington Avenue and the south line of above said quarter section; then northerly along the westerly line of Burlington Avenue, a distance of 258 feet to the point of beginning; thence northerly along the westerly line of Burlington Avenue to the south line of an alley abutting Darling's First Addition; thence westerly along the south line of said alley, a distance of 115 feet; thence southerly and parallel to the westerly line of Burlington Avenue to a point 258 feet north of the south line of said quarter section; thence easterly and parallel to said section line, a distance of 115 feet to the point of beginning.

and

That part of the Southwest Quarter (SW_{1/4}) of Section 13, Township 102 North, Range 40 West in Nobles County described as follows: Commencing at the northwest corner of Section 13; thence easterly along the south line of said section, a distance of 351 feet to the point of beginning; thence northerly and parallel to the westerly line of said quarter section, a distance of 466.5 feet; thence easterly and parallel to the southerly line of said quarter section, a distance of 109 feet, thence northerly and parallel to the west line of said quarter section to the south line of alley abutting Darling's First Addition; thence easterly and along the south line of said alley to a point 115 feet westerly of the westerly line of Burlington Avenue; thence southerly and parallel to the westerly line of Burlington Avenue to the southerly line of said quarter section; thence westerly along said quarter section line to the point of beginning.

Section 2. The quantity of land embraced within the foregoing descriptions and bounded and described is 2.7 acres.

Section 3. Notice was duly given to the Board of Commissioners for Nobles County and the Board of Commissioners for Worthington Township on January 5, 1966, and to the owners of said property on December 14, 1965, that said matter was being considered by the City Council of the City of Worthington and a hearing was duly held by the City Council of the City of Worthington, on the proposed annexation after publication of notice of hearing as required by the City Charter.

Page 2 -- Ordinance No. 305

Section 4. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Worthington, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon and is completely surrounded by land now within the corporate limits of said City and is so conditioned as properly to be subjected to City government.

Section 5. The corporate limits of the city are hereby extended to include the property described in Section 1, and the same is hereby annexed to, and included in the City as effectually as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

Section 7. This ordinance shall take effect upon its passage and publication and upon the filing of the certified copies as directed in Section 6.
