## OPPRIMENDE NO. 306

AN GEDINANCE EXTENDED THE COSPONATE LIGHTS OF THE CLIT OF WORTHHOUSE, MICH SOTA, TO INCIDE CHEATH UPPLATED LANDS.

The City Council of the City of Worthington to Ordains

Section 1. The territory hereinefter described, is now owned by the City of Worthington; and whereas said property is cituated outside of, but contiguous to, and abutting on the corporate limits of the City, the City Council of said City of Worthington has determined to have such land included within the City of Worthington, Minnesota:

Cormencing at a point on the Section line between Sections Thirteen and Twenty-Four (13 & 24), Township One Hundred Two (102) North, Hange Forty (40) West, 70 feet West and 35 feet South of the Southwest Corner of Lot Might (8), of the West and 35 feet South of the Southwest Corner of Lot Might (8), of the West of North Worthington Addition, City of Worthington; thence Northerly and parallel with the West line of Section Thirteen (13), a distance of 665.5 feet; thence westerly and parallel to the South section line for 115 feet; thence Southerly and parallel to the West line of said section for 15 feet; thence Easterly and parallel to the South line of said section for 160.3 feet; thence Easterly and parallel to the South line of said section for 160.3 feet; thence Northerly 15 feet to the point of beginning.

Section 2. The quantity of land embraced within the foregoing description, and bounded and described is .017 acres.

Section 3. Notice was duly given the Board of Commissioners for Hobles County and the Seard of Commissioners for Worthington Township on February 15, 1966, that said matter was being considered by the City Council of the City of Worthington and a hearing was duly held by the City Council of the City of Worthington, on the proposed amazation after publication of notice of hearing as required by City Charter.

Section h. The City Council hereby determines (1) that the enceration will be to the best interests of the City of Worthington, Minnesota, and of the territory effected; (2) that the territory described herein abute upon the City and is no conditioned as properly to be subjected to city government.

Section 5. The corporate limits of the city are hereby extended to include the property described in Section 1, and the same is hereby annexed to, and included in the City as effectually as if it had originally been a part thereof.

Section 6. The City Clork is hereby directed to file certified copies of this ordinance with the Einmesota Nunicipal Commission, the County Auditor and the Secretary of State.

Section 7. This ordinance shall take effect upon its passage and publication and upon the filing of the certified copies as directed in Section 6.
