ORDINANCE NO. 128

AN ORDINANCE ANNEXING TO AND INCORPORATING INTO THE CITY OF GLENWOOD, CITY PARK PROPERTY IN SECTION SEVEN, TOWNSHIP ONE HUNDRED TWENTY-FIVE, RANGE THIRTY-SEVEN, AND DECLARING THE SAME TO BE A PART OF AND AN ADDITION TO THE CITY OF GLENWOOD, MINNESOTA

THE CITY OF GLENWOOD DOES ORDAIN:

SECTION I. The City of Glenwood is the owner in fee simple of the following described property situated in the County of Pope, State of Minnesota:

The North Twenty-eight (28) acres of the West half of the East half of the Northwest Quarter (NW<sup>1</sup>/<sub>4</sub>) of Section Eighteen (18), Township One Hundred Twenty-five (125), Range Thirty-seven (37), which is also described as follows:

Beginning at the North 1/16 corner of the Northwest Quarter (NW<sup>1</sup>/<sub>4</sub>) of Section Eighteen (18), Township One Hundred twenty-five (125), Range Thirty-seven (37), thence South on said 1/16 line 1898.4 feet, thence East 665.4 feet, thence North 1907.7 feet to the North line of said Northwest Quarter (NW<sup>1</sup>/<sub>4</sub>) of Section Eighteen (18), thence West 661 feet, more or less, to the point of beginning.

which said premises abut the incorporated limits of the City of Glenwood.

SECTION II. Such premises as described in Section I hereof are hereby annexed and made a part of the City of Glenwood, Minnesota.
