An Ordinance Extending the Corporate Limits of the Village of Hamburg, to Include certain Unplatted lands, not exceeding 200 acres.

Section 1. = A petition having been filed with the Governing Body of the Village of Hamburg by Clarence H. Hoernemann and Rosella A. Hoernemann the owners of the Following described real estate, to have such lands included within the Village of Hamburg, Minnesota.

That part of the Northwest Quarter of the Northeast Quarter of Section 33, Township 115 Range 26, described as follows: Commencing at a point on the North line of said Northwest Quarter of the Northeast Quarter, at a distance of 300 feet West of the Northeast corner of said Northwest Quarter of the Northeast Quarter; thence East on said North line of said Northwest Quarter of the Northeast Quarter, a distance of 80 feet; thence South parallel to the East line of said Northwest Quarter of the Northeast Quarter, a distance of 220 feet; thence West parallel to the North line of said Northwest Quarter of the Northeast Quarter, a distance of 80 feet; thence North parallel to the East line of said Northwest Quarter of the Northeast Quarter, a distance of 220 feet to the point of beginning; the North 33 feet thereof subject to road easement.

Section 2. = The quantity of land embraced within the foregoing description, and bounded as described is .40 acres.

Section 3. = The Village Council hereby determines (1) That the annexation will be to the best interest of the Village of Hamburg, Minn., and of the territory affected; (2) that the territory described herein abutts upon the Village of Hamburg, and is so conditioned as properly to be subjected to Village Government.

Section 4. = Therefore, the Village of Hamburg, Minn., hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to and included in the Village of Hamburg, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. = This ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
