

Ordinance # 48

An Ordinance Extending the Corporate Limits of the Village of Hamburg, to include certain unplatted lands, not exceeding 200 acres.

Section 1. - A petition having been filed with the Governing body of the Village of Hamburg by Arthur Buckentin & Magdalena Buckentin, the owners of the following described real estate, to have such lands included within the Village of Hamburg, Minnesota:

That part of the Northeast Quarter of the Northeast Quarter of Section 32, Township 115, Range 26, described as follows: Commencing at a point on the North line of said Section at a distance of 253.5 feet West of the Northeast Corner, of said Section, which said point is the point of beginning of this description; thence running West on the North line of said Section 32, a distance of 100 feet to a point; thence turning and running South parallel to the Section line between Sections 32 and 33, a distance of 260 feet to a point; thence turning and running East parallel to the North line of said Section 32, a distance of 353.50 feet to a point on the East line of said Section 32; thence turning and running North along the East line of said Section 32, a distance of 45.5 feet to a point; thence turning and running West parallel to the North line of said Section 32, a distance of 253.5 feet to a point; thence turning and running North parallel to the East line of said Section 32, a distance of 214.5 feet to the place of beginning. Containing .96 of an acre, more or less.

Section 2. = The quantity of land embraced within the foregoing description, and bounded as described is .86 acres.

Section 3. = The Village Council hereby determines (1) that the annexation will be to the best interest of the Village of Hamburg, Minn. and of the territory affected; (2) that the territory described herein abuts upon the Village of Hamburg, and is so conditioned as properly to be subjected to Village Government.

Section 4 = Therefore, the Village of Hamburg, Minn., hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to and included in the Village of Hamburg, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. = This ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication. Passed by the Village Council this 7th day of June 1966
