
The Municipal Commission acknowledges receipt of your Ord. No. 100 and filing fees and finds that all the requirements of the Commission Act have been met.

COUNCIL NO. 100

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF POLY TO INCLUDE CERTAIN UNINCORPORATED PLANTED AND UNPLANTED LAND NOT EXCEEDING 200 ACRES IN AREA ADJACENT UPON THE VILLAGE LIMITS.

WHEREAS, a certain petition dated April 12th, 1956, requesting annexation of the territory hereinafter described was duly presented to the council on the 1st day of May, 1956; and

WHEREAS, the quantity of land enclosed within the area described in the petition and bounded as described is 60 acres of planted and unplanted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by the owner; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries adjoin upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the village limits at the northeast boundary thereof;

THE COUNCIL OF THE VILLAGE OF POLY, MINNESOTA, ordains:

Section 1. The Village Council hereby directs that the annexation will go to the best interests of the village and of the territory affected; (A) that the territory described herein abut upon the village limits and is urban or suburban in character and (B) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the village are hereby extended to include the planted and unplanted land described as follows and the same is hereby annexed to and included within the village as effectually as if it had originally been a part thereof:

Commencing at the intersection of the South Line of the Great Northern Railway Right-of-Way with the East Right-of-Way Line of Minnesota Trunk Highway No. 203 thence southerly along said East Right-of-Way Line of Minnesota Trunk Highway No. 203 to the northeast corner of Lot Fifteen 1161, Block One 111, Polley Development Plat, being part of the Northeast Quarter (NE 1/4) of Section Thirty-five (35), Township Thirteen (13) North, Range Twenty-nine (29), U.S.A., thence southerly a distance of 100.19 feet, thence northerly a distance of 100 feet, thence westerly a distance of 100.19 feet, thence northerly and parallel with the first described line to the intersection of the South Line of the Great Northern Railroad Right-of-Way and there terminating, and

Blocks One (1), Two (2), Three (3) Five (5) and Six (6), and Lots One (1), Three (3), Four (4), Five (5), Six (6), Seven (7), Eight (8), Nine (9), Ten (10), Eleven (11), Twelve (12), Thirteen (13), Fourteen (14), Fifteen (15), Sixteen (16), Seventeen (17), Eighteen (18), Nineteen (19), Twenty (20), Twenty-one (21) and Twenty-two (22), of Block Four (4), Polley Development Plat, all of which is in the name of Polley Companies Corporation, a Minnesota corporation.

Section 3. Filing. The village clerk is hereby directed to file certified copies of this ordinance with the Anoka County Clerk's Office, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage
and publication and the filing of the certified copies as directed in Section 3.
