AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ADJUTING THEREON.

This property is owned by Sam Williams and is located immediately west of 3rd St. N. E. between 13th Ave. NE and 14th Ave. NE in Hannan Daudler Addition.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory is completely surrounded on all sides by land already included within the corporate limits of the City and is deemed to be urban in character;

THE COMMON COUNCIL OF THE CITY OF AUSTIN HEREBY ORDAINS:

SECTION 1. Territory Annexed. The corporate limits of the City of Austin, Minnesota, are hereby extended to include the territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

Commencing at the Southeast corner of the Northeast Quarter of the Southeast Quarter of Section 34, Township 103 North, Range 13 West; then as West along the South line of said quarter quarter section a distance of 100.2 ft. to the west property line of 3rd Street Northeast; thence northwesterly along said west property line to a point where the South line of Lot 5, Block 1 of Hannan Daudler's Addition extended West crosses the west property line of said 3rd St. N.E. This point being the point of beginning; thence west along the South line of said Lot 5 extended a distance of 110 ft.; thence North at a deflection angle to the right of 89° 41' a distance of 54.75 ft.; thence east at a deflection angle to the left of 89° 41' a distance of 64.0 ft.; thence North at a deflection angle to the right of 89° 41' a distance of 109.75 ft.; thence West at a deflection angle to the left of 89° 41' a distance of 50 ft.; thence North at a deflection angle to the right of 89° 41' a distance of 214.25 ft.; thence East at a deflection angle to the right of 89° 19' a distance of 104.3 ft. to the West property line of 3rd St. N.E.; thence southerly along said West property line to the point of beginning.

SECTION 2. Filing. The City Recorder is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the County in which the property is located, and the Minnesota Municipal Commission.
