ORDINANCE NO. 1075

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ADJOINING THEREON.

This property is owned by Roy King and is located on the west side of 3rd Street NE between 12th Avenue NE and 13th Avenue NE in Homan Daudler Addition.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough; and

WHEREAS, this territory is completely surrounded on all sides by land already included within the corporate limits of the City and is deemed to be urban in character;

THE COMMON COUNCIL OF THE CITY OF AUSTIN HEREBY ORDAINS:

**SECTION 1. Territory Annexed.** The corporate limits of the City of Austin, Minnesota, are hereby extended to include the territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

Beginning at a point 106.2 ft. west of the Southeast corner of the Northeast Quarter of the Southeast Quarter of Section 24, Township 103 North, Range 18 West, thence West along the South line of said quarter, quarter section a distance of 300 ft.; thence North at a deflection angle of 89° 21' right a distance of 50 ft.; thence East at a deflection angle of 90° 19' right to the west property line of 3rd Street N.E.; thence southeasterly along said west property line to the point of beginning.

**SECTION 2. Filing.** The City Recorder is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.

**SECTION 3. Effective Date of Annexation.** This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.
