ORDINANCE NO. 1076

AN ORDINANCE EXTENDING THE CORPORATION LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ADJUSTING THEREON

This property is owned by Corbie McFarland and is located on 5th Avenue NW between 10th and 15th Streets NW.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City and is deemed to be urban in character;

The Common Council of the City of Austin hereby ordains:

SECTION 1. Territory Annexed. The corporate limits of the City of Austin, Minnesota, are hereby extended to include the territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

Commencing at the southeast corner of the northeast one quarter of the northwest one quarter of Section 4, Township 102 North, Range 10 West; thence westerly along the south line of said one quarter, one quarter section a distance of 660.67 feet; thence northerly at a deflection angle to the right of 89° 43' a distance of 337.9 feet; thence easterly at a deflection angle to the right of 90° 00' a distance of 71.43 feet to the point of beginning, this point also being in the north line of the south one half of Outlot 10 located in the northwest one quarter of Section 4; thence southerly at a deflection angle to the right of 90° 00' a distance of 150 feet; thence easterly at a deflection angle to the left of 90° 00' a distance of 71.43 feet; thence northerly at a deflection angle to the left of 90° 00' a distance of 71.43 feet to the point of beginning.

SECTION 2. Filing. The City Recorder is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.

SECTION 3. Effective date of Annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City and is deemed to be urban in character;

The Common Council of the City of Austin hereby ordains:

SECTION 1. Territory Annexed. The corporate limits of the City of Austin, Minnesota, are hereby extended to include the territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

Commencing at the southeast corner of the northeast one-quarter of the northwest one-quarter of Section 4 Township 102 North, Range 13 West; thence westerly along the south line of said one-quarter, one-quarter section a distance of 660.47 feet; thence northerly at a deflection angle to the right of 89° 48' 00" a distance of 337.9 feet; thence easterly at a deflection angle to the right of 90° 00' 00" a distance of 71.43 feet to the point of beginning, this point also being on the north line of the south one-half of Outlot 10 located in the northwest one-quarter of Section 4; thence southerly at a deflection angle to the right of 90° 00' 00" a distance of 150 feet; thence easterly at a deflection angle to the left of 90° 00' 00" a distance of 71.43 feet; thence northerly at a deflection angle to the left of 90° 00' 00" a distance of 150 feet; thence westerly at a deflection angle to the left of 90° 00' 00" a distance of 71.43 feet to the point of beginning.

SECTION 2. Filing. The City Recorder is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.

SECTION 3. Effective date of Annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.
