

ORDINANCE NO. 1077

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ADJUTING THEREON.

This property is located on the west side of 12th Street SW (T. H. No. 105) and on the north side of 19th Avenue SW in Southgate Addition

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City and is deemed to be urban in character;

THE COMMON COUNCIL OF THE CITY OF AUSTIN HEREBY ORDAINS:

SECTION 1. Territory Annexed. The corporate limits of the City of Austin, Minnesota, are hereby extended to include the territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

Commencing at the southeast corner of Section 9, Township 102 North, Range 10 West; thence northerly along the east line of said section a distance of 678 ft.; thence easterly at a deflection angle to the left of $89^{\circ} 45'$ a distance of 33 ft. to the point of beginning; thence westerly along this same line a distance of 200 ft.; thence northerly at a deflection angle to the right of $89^{\circ} 45'$ a distance of 452 ft.; thence easterly at a deflection angle to the right of $90^{\circ} 15'$ a distance of 207 ft.; thence southerly at a deflection angle to the right of $90^{\circ} 15'$ a distance of 462 ft. to the point of beginning.

SECTION 2. Filing. The City Recorder is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.

SECTION 3. Effective Date of Annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.


