ORDINANCE NO. 556 FROPOSED OPDINANCE PO. 1-24

AN ORDINANCE ANNEXING PART OF THE NORTHEAST QUAPTER OF THE NORTHEAST QUARTER OF SECTION 12, TOWNSHIP 35 NORTH, RANGE 31 WEST, AND A PART OF SECTION 7, TOWNSHIP 35 NORTH, RANGE 30 WEST, BOTH IN SHERBURNE COUNTY, MINNESOTA, INTO THE CORPORATE LIMITS OF THE CITY OF ST. CLOUD, MINNESOTA

WHEREAS the owner of the following described tract of land, has presented to, and filed with, the Council of the City of St. Cloud, Minnesota its petition requesting that the following described tract of land, situated in the County of Sherburne, State of Minnesota, to-wit:

All that part of the NE 1/4, NE 1/4, Sec. 12, Twp. 35N, R31W, described as follows: Beginning at a point on the north line of said NE 1/4, NE 1/4, said point being 274' East of the NW corner of said NE 1/4, NE 1/4, thence south along a line being 274' East of and parallel with the west line of said NE 1/4, NE 1/4 to the intersection of said line with the southerly R/W line of Minnesota Boulevard S. WHEREAS, the Planning Commission of the City of St. Cloud Minnesota, in writing, has recommended to the Council to annex the above described tract of land into the City of St. Cloud; and WHEREAS, after due investigation and consideration, it is hereby found, determined and declared:

- That said above described tract of land adjoins and lies 1. immediately adjacent to the corporate limits of the City of St. Cloud, and that no part thereof is included within the corporate limits of any other municipality;
- 2. That said above described tract of land is not platted and is less than two hundred (200) acres in area;
 - 3. That copies of the said petition have been filed with the Minnesota Municipal Commission, the town board of the Township of Haven, and the county board of the County of Sherburne, Minnesota;
 - 4. That more than thirty days have elapsed since said petition was filed with the Council of the City of St: Cloud, and that no written objections to the annexation have been received by the City of St. Cloud;
 - 5. That annexation of the said tract of land will be to the best interest of:
 - (a) The City of St. Cloud, all the owners of said tract, and, (b) (c) the territory affected.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF ST. CLOUD HEREBY ORDAINS: That said above described tract of land be and the same hereby is, annexed to the City of St. Cloud, Minnesota and declared to be a part thereof and within the corporate limits thereof.
