



ORDINANCE NO. 69

AN ORDINANCE ANNEXING CERTAIN
PROPERTY TO THE VILLAGE OF
VADNAIS HEIGHTS.

WHEREAS, a Petition for Annexation has been
made by the owners of the following described property:

"Lots B, C, D, E, and F,
Registered Land Survey
No. 69, Ramsey County,
Minnesota."

which property is surrounded by the Village of Vadnais
Heights on three (3) sides by more than seventy-five
(75%) percent thereof, and

WHEREAS, the Village of Vadnais Heights on
May 4, 1966, notified the Town Board of the Town of
White Bear of the intent of Vadnais Heights to annex the
above described property, pursuant to Minn. Stat. Sec.
414.03, Sub. 2, as amended, and

WHEREAS, the Town of White Bear by resolution
of the Town Board adopted May 9, 1966, resolved not to
object to the annexation petition of the owners of the
above described property, and

WHEREAS, the Village Council of the Village
of Vadnais Heights has determined that the above described

property is properly subjected to Village government and has determined that it is in the best interests of the Village of Vadnais Heights that said property be annexed to the Village of Vadnais Heights.

NOW, THEREFORE, Pursuant to the above procedure and determination,

The Village Council of Vadnais Heights, Minnesota, hereby ordains:

I.

"Lots B, C, D, E, and F, Registered Land Survey No. 69, Ramsey County, Minnesota," is hereby annexed to the Village of Vadnais Heights and the same shall hereafter be administered as a portion of this Village pursuant to Minn. Stat. Sec. 414.03, Sub. 2, as amended.

II.

This ordinance shall take effect and be in force from and after its passage and certified copies shall be tendered to the Ramsey County Auditor, the Secretary of State, and the Municipal Commission.
