ORDINANCE NO. 278

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF HUTCHINSON,  
MCLEOD COUNTY, MINNESOTA

(City of Addition)

The City Council of the City of Hutchinson ordains:

SECTION I. WHEREAS, Elmer & Wilma Jean Merickel are the owners of the following described lands lying and being in the County of McLeod and State of Minnesota and described as follows, to-wit:

Beginning at a point 5 75/100 chains South of the Northwest corner of the Southeast Quarter of Section 1, Township 116, Range 30, and running thence South 8 5/10 chains; thence East 5 32/1000 chains to center of public road; thence North-easterly along center of public road to a point 5 75/100 chains South of the North line of said Southeast Quarter, Section 1, Township 116, Range 30; thence West 8 366/1000 to place of beginning; and

That part of Lot 94 of Lynn Addition to Hutchinson, Minnesota according to the Plat thereof of record and on file in the Office of the Register of Deeds, McLeod County, Minnesota, described as follows: to-wit: beginning at the Northwest corner of said Lot 94; thence South, along the West line of said Lot 94, a distance of 9.0 feet; thence deflect 86°04' left to the Northwesterly right-of-way line of Dale Street; thence Northeasterly, along said right-of-way line, a distance of 32.76 feet to the North line of said Lot 94; thence West, along said North line, to the point of beginning.

SECTION II. AND WHEREAS, said above described land is contiguous to and abuts upon the City Limits of the City of Hutchinson,

SECTION III. AND WHEREAS, the City Council of the City of Hutchinson deems it desirable and in the best interest of the City of Hutchinson to annex the above described lands to the City of Hutchinson.

SECTION IV. NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Hutchinson that the lands described above be and they hereby are annexed to the City of Hutchinson and from and after the date of passage of this Ordinance, said lands shall become a part and portion of the City of Hutchinson with the same force and effect as though originally a part of the City.

SECTION V. This Ordinance shall take effect and be in force from and after its publication, and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.
