ORDINANCE NO. 60

ORDINANCE ANNEXING CERTAIN LANDS

TO

THE VILLAGE OF STEWARTVILLE

WHEREAS, a petition for annexation of lands hereinafter described duly signed by all of the owners of the land proposed for annexation has been filed with the Village Council of the Village of Stewartville; and

WHEREAS, copies of said petition have been filed with the Minnesota Municipal Commission, the High Forest Town Board, and the Olmsted County Board; and whereas, more than thirty (30) days have elapsed since filing copies of said petition with the Minnesota Municipal Commission, the High Forest Town Board, and the Olmsted County Board and no written objections to the proposed annexation have been filed with the Village of Stewartville.

AND WHEREAS, the Village Council of Stewartville, Minnesota, has determined that the annexation will be to the best interests of the Village of Stewartville and the territory affected;

The Village Council of Stewartville ordains:

1. The following described lands are hereto annexed and made a part of the Village of Stewartville. Lands situate in the County of Olmsted, State of Minnesota, described as follows, to-wit:

A part of the Northwest Quarter of Section 2, Township 104 North, Range 14 West, described by metes and bounds as follows: Commencing at the Northeast Corner of said Quarter Section, thence West along the North line of said Quarter Section a distance of 208.56 feet for a place of beginning, thence South at a deflection angle of 91°52' to the left and parallel with the East line of said Quarter Section a distance of 938.19 feet, thence East at a deflection angle of 88°08' to the left and parallel with the North line of said Quarter Section a distance of 208.56 feet to a point in the East line of said Quarter Section, thence South along said East line at a deflection angle of 88°08' to the right a distance of 327.48 feet, thence West at a deflection angle of 91°52' to the right a distance of 541.60 feet, thence North at right angles a distance of 1265.0 feet to a point in the North line of said Quarter Section, thence East at right angles along said North line a distance of 291.81 feet to the place of beginning, subject to easements on record, containing 10.64 acres of unplatted lands.
