EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO THE EAST.

WHEREAS, the owners of the property hereinafter described filed a Petition requesting the annexation of the territory hereinafter described which was duly presented to the Council,

AND WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is less than 200 acres of unplatted land,

AND WHEREAS, the Petition was signed by all the owners,

AND WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed,

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF AUSTIN, MINNESOTA, DO ORDAIN:

SECTION 1: The City Council hereby determines that the annexation shall be to the best interests of the City and of the territory affected; and that the territory described herein abuts the City limits and is urban or suburban in character; and that none of said territory is now included within the limits of any city, village or borough.

SECTION 2: The Corporate limits of the City are hereby extended to include the platted lands as follows, and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

These portions of Section 35, Township 103 North, Range 10 West, Major County, Minnesota, hereinafter described as Tracts A, B, C, D, E and F, to-wit:

Tract A: The following portion of the Northwest Quarter of the Southeast quarter of said Section 35: Beginning on the North line of said Quarter-Quarter Section at a point 50.7 feet West of the Northeast Corner thereof, which point lies on the Northwestly right-of-way line of the Chicago Great Western Railway Company; thence West 13.3 feet along the North line of said Quarter-Quarter Section; thence South 23.00 feet at a deflection angle of 90° 00' left, to the Northwestly line of said railroad right-of-way; thence Northeastly 23.36 feet along the said right-of-way line to the point of beginning, containing .000 acres.

Tract B: The following portion of the Northwest Quarter of the Southeast quarter of said Section 35: Beginning at the Southeast corner of said Quarter-Quarter Section; thence West 66.0 feet along the South line of said Quarter-Quarter Section; thence Westly 345.96 feet

at a deflection angle of $88^{\circ} 53'$ right; thence Northerly 235.11 feet at a deflection angle of $9^{\circ} 40'$ left, to the Southeastly right-of-way line of the Chicago Great Western Railway Company; thence Northeastly 112.02 feet at a deflection angle of $36^{\circ} 06'$ right, along said railroad right-of-way line; thence Southerly 326.0 feet at a deflection angle of $143^{\circ} 54'$ right; thence Southerly 866.42 feet at a deflection angle of $9^{\circ} 40'$ right, to the point of beginning, containing 1.65 acres.

Tract C: The following portion of the Southwest quarter of the Northeast quarter of said Section 35: Beginning on the East line of said quarter-quarter Section at a point 79.13 feet North of the Southeast corner thereof, which point lies on the Northeastly right-of-way line of the Chicago Great Western Railway Company; thence North 1235.07 feet on the East line of said quarter-quarter section to the Northeast corner thereof; thence West 66 feet along the North line of said quarter-quarter section; thence South on a course parallel to the East line of said quarter-quarter section, to the South line thereof; thence East 15.3 feet on the South line of said quarter-quarter section to the Northeastly right-of-way line of said railroad company; thence Northeastly 93.93 feet along said Northeastly right-of-way line to the point of beginning; containing 1.97 acres.

Tract D: The following portion of the Northwest quarter of the Northeast quarter of said Section 35: Beginning at the Southeast corner of said quarter-quarter section; thence West 66.0 feet on the South line of said quarter-quarter section; thence Northeastly 283.61 feet on a curve to the right with a radius of 1145.92 feet and through a central angle of $13^{\circ} 47'$ to the end point of said curve; thence on a reverse curve Northeastly and Northerly 267.73 feet on a curve to the left with a radius of 1145.92 feet and through a central angle of $13^{\circ} 47'$ to the end point of said curve, which point lies on the East line of said quarter-quarter section 546.22 feet North of the Southeast corner thereof; thence South 546.21 feet on the East line of said quarter-quarter section to the point of beginning; containing .61 acres.

Tract E: The following portion of the Northwest quarter of the Southeast quarter and the Southwest quarter of the Northeast quarter of said Section 35: Beginning at the intersection of the Northwestly line of the right-of-way of the Chicago Great Western Railway Company and the East line of the Southwest quarter of the Northeast quarter of said Section 35, which point lies 79.13 feet North of the Southeast corner of said quarter-quarter section and is at the South end of the East line of Tract C above described; thence South 79.13 feet to the Southeast corner of said quarter-quarter section; thence Southwestly 144.75 feet to the most Northerly corner of Tract D above described, which point lies on the Southeastly line of

said railroad right-of-way; thence Southwesterly 112.02 feet along the common boundary between said railroad right-of-way and the Northwesterly line of said Tract B, to the North end of the West line of said Tract B; thence Northerly 169.72 feet along the extended West line of said Tract B to the Northwesterly line of said railroad right-of-way; thence Northwesterly along said Northwesterly line of said railroad right-of-way to the Southwest corner of Tract A; thence continuing along the common boundary between said railroad right-of-way on the one hand and the above described Tracts A and C on the other, to the point of beginning; containing .34 acres.

Tract F: The Northeast quarter of the Northeast quarter of said Section 35 except that part thereof lying East and Southeast of the Northwesterly line of the right-of-way of the Chicago Great Western Railway Company and except that part thereof lying North of a straight line beginning on the East line of said quarter-quarter Section at a point 66.0 feet south of the Northeast corner thereof and running thence West through said quarter-quarter Section on a course parallel to the North line thereof; containing 24.42 acres.

SECTION 3: The City Recorder is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

SECTION 4: This Ordinance takes effect on its passage and publishing and the filing of the certified copies as directed in Section 3.
