
Dear Mr. Hanson:

ORDINANCE NO. 1099

EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO THE WEST.

WHEREAS, the owners of the property hereinafter described called a Petition requesting the annexation of the territory hereinafter described which was duly presented to the Council,

AND WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is less than 200 acres of platted land, no part of which is included within the limits of an incorporated city, village, or borough,

AND WHEREAS, the Petition was signed by all the owners,

AND WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed,

NOW, THEREFORE, THE COUNCIL COUNCIL OF THE CITY OF AUSTIN, ORDEAINE, TO ORDER:

SECTION 1: The City Council hereby determines that the annexation shall be to the best interests of the City and of the territory affected; and that the territory described herein abuts the City limits and is urban or suburban in character; and that none of said territory is now included within the limits of any city, village or borough.

SECTION 2: The corporate limits of the City are hereby extended to include the platted lands as follows, and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

- (1) Starting at the Southeast corner of the following described tract (hereinafter called Tract A), to-wit: The West three-quarters of the North Half of the Northwest Quarter of Section 4, Township 103 South, Range 18 West; (2) thence North 400.03 feet along the East Line of Tract A to the Southeast corner of the North one-third of the South Half of Tract A, which point is the point of beginning of the tract being described;
- (3) thence continuing North 224.03 feet along the East Line of Tract A to the Northwest corner of the South Half of Tract A, which point is the Northwest corner of the tract being described; (4) thence West 376.99 feet at a deflection angle of 39° 59' left, and along the North Line of the South Half of Tract A, to the Northwest corner of the tract being described; (5) thence Southwesterly 6.01 feet at a deflection angle of 92° 57' left to the last end of the last Northerly line of Bel-Air Ranch Addition to the City of Austin, which point lies on the last line of a public street of said city; (6) thence continuing Southwesterly 133.94 feet along an extension of this last described line and along the boundary of said Bel-Air Fourth Addition

and along the East line of said public street, to the Northwest corner of Lot 6 in Block 3 of said Bel-Air Fourth Addition; (7) thence East 663.44 feet at a deflection angle of $90^{\circ} 45'$ left, along the North line of Block 3 of said Fourth Addition and said line extended to the East line of the public street of said city lying immediately East of said Block 3; (8) thence South 76.65 feet at a deflection angle of $90^{\circ} 54'$ right, along the East line of said street and the boundary of said Fourth Addition, to a point 5 feet North of the Northwest corner of Lot 3 in Block 1 of said Fourth Addition; (9) thence 121.23 feet East at a deflection angle of $90^{\circ} 45'$ left, on a line parallel to the North line of said Block 1; (10) thence South 5 feet at a deflection angle of $90^{\circ} 57'$ right, to the Northwest corner of said Block 1, which point lies on the South line of the North one-third of the South Half of Tract A; (11) thence East 193.00 feet at a deflection angle of $90^{\circ} 57'$ left, to the point of beginning, making an internal angle of $54^{\circ} 57'$ at said point, being a part of said Tract A and containing 3.766 acres according to the survey thereof;

SECTION 3: The City Recorder is hereby directed to file certified copies of this Ordinance with the Hennepin Municipal Commission, the Secretary of State and the County Auditor.

SECTION 4: This Ordinance takes effect on its passage and publishing and the filing of the certified copies as directed in Section 3.


1. That he is the duly appointed, qualified, and acting Recorder of the City of Austin
