Member Howard Krengel introduced the following Ordinance and moved its adoption:

ORDINANCE NO. 66

Being an Ordinance for changing of the annual Village Election date.

The Village Council of Eden Valley, Minnesota ordains:

SECTION NO. 1

That, the annual Village Election which is held on the first Tuesday after the first Monday in December, be changed to the Optional Village Election date, being the first Tuesday after the first Monday in November.

SECTION NO. 2

This Ordinance shall take effect and be in force after its passage and publication.
