
Dear Mr. Rosevold:



ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MANKATO TO INCLUDE CERTAIN UNPLATTED LANDS NOT EXCEEDING TWO HUNDRED ACRES, PURSUANT TO M.S.A SECTION 414.03, SUBDIVISION 2, AND ALL LAWS AMENDATORY AND SUPPLEMENTARY THERETO, AND IN ACCORDANCE WITH THE RULES OF PROCEDURE OF THE MUNICIPAL COMMISSION.

The City of Mankato, Minnesota, does ordain:

I.

A Petition has been filed with the City Clerk of the City of Mankato, Minnesota, by Production Credit Association of Mankato, a United States Corporation, of the County of Blue Earth and State of Minnesota, as owners of the following described real estate, to have such lands included in the City of Mankato, Blue Earth County, Minnesota, to-wit:

The West Six (6) acres of the East-half of the Northeast quarter of the Northeast quarter ($E\frac{1}{2} NE\frac{1}{4} NE\frac{1}{4}$) of Section Seventeen (17) Township one hundred eight (108), Range Twenty-six (26) West, except the Southerly 1099.4 feet, and except Minnesota State Highway right of way Easement; being 170.6 feet, more or less.
ALSO DESCRIBED AS:

The West Six (6) acres of the East Half of the Northeast quarter of the Northeast quarter ($E\frac{1}{2} NE\frac{1}{4} NE\frac{1}{4}$) of Section Seventeen (17) Township One Hundred Eight (108) Range Twenty-six (26) excepting the following:

- 1) The South 550 feet of said West 6 acres as more fully described in deeds appearing of record in the office of the Register of Deeds for Blue Earth County in Book 177 of Deeds, page 84 and Book 177 of Deeds at page 432.
- 2) The North 379.4 feet of the South 929.4 feet of the West 6 acres as more fully described in deed appearing of record in Book 181 of Deeds at page 125.
- 3) The North 170 feet of the South 1099.4 feet of said West 6 acres as more fully described in Book 180 of Deeds at page 619. Subject, however, to highway easement in favor of the State of Minnesota appearing of record in Book 139 of Deeds at page 330 and Highway right-of-way acquired by the State of Minnesota as more fully described in the final certificate appearing in Book 169 of Deeds at page 24.

II.

The quantity of land embraced within the foregoing description is unplatted and does not exceed 200 acres and is not within the corporate limits of any city or village and is contiguous to and abutting upon a portion of the easterly boundary of the City of Mankato, Minnesota, an incorporated city, having a population of not less than 10,000 nor more than 30,000, pursuant to the last census. That it appears from the records of the Clerk of the City of Mankato, Minnesota, that copies of the petition

asking for annexation were filed with the Minnesota Municipal Commission, the Mankato Township Town Board, and the Blue Earth County Board, and that more than thirty days have elapsed since said filing and that no objections to said annexation were submitted.

III.

The City Council of Mankato, Minnesota, hereby determines that the annexation of the above described property will be to the best interests of the municipality and of the land affected and that the above described tracts and parcels of land are so conditioned as properly to be subjected to city government and are hereby annexed to and declared to be an addition to the City of Mankato, as effectually as if it had originally been a part thereof and the corporate limits of the City of Mankato, Minnesota are hereby extended to include said property.

The City Clerk is hereby directed to file certified copy of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State, and this ordinance takes effect ten (10) days after its passage and publication and upon the filing of certified copies, as herein described.
