
SUBJECT: WAYER AMBULATION A-1017

ORDINANCE NUMBER 41

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF MAYER, CARVER COUNTY, MINNESOTA TO INCLUDE CERTAIN PLATTED LAND.

WHEREAS, A certain petition dated June 2, 1966 requesting annexation of the territory described below was duly presented to the Council on the 2nd day of June, 1966, ~~and~~

AND WHEREAS, it appears that said petition is proper and no objections have been raised during the 30 day waiting period.

The Council of the Village of Mayer, Carver County, Minnesota ordains:

SECTION 1. It is hereby determined that the territory described below abuts upon the Village and is so conditioned as properly to be subjected to Village Government.

SECTION 2. The corporate limits of the Village of Mayer are hereby extended to include the following described premises lying and being in the County of Carver and State of Minnesota and described as follows, to-wit:

TRACT 1. That part of the Northwest  $\frac{1}{4}$  of Section 6, Township 116, Range 25, Carver County, Minnesota, described as follows: Commencing at the Northwest corner of said Northwest  $\frac{1}{4}$ ; Thence East along the North line of said Northwest  $\frac{1}{4}$  a distance of 333.0 feet; thence South parallel with the West line of said Northwest  $\frac{1}{4}$ , a distance of 996.6 feet; thence West parallel with said North line 130.0 feet; thence North parallel with said West line 40.0 feet; thence East parallel with said North line 130.0 feet; to the point of beginning.

TRACT 2. That part of the Northwest  $\frac{1}{4}$  of section 6, Township 116, Range 25, described as follows: Commencing at the Northwest corner of said Northwest  $\frac{1}{4}$ ; Thence East along the North line of said Northwest  $\frac{1}{4}$  a distance of 333.0 feet; Thence South parallel with the West line of said Northwest  $\frac{1}{4}$  a distance of 996.0 feet to the actual point of beginning; Thence continuing South along said parallel line 10.0 feet; thence East parallel with said North line 400.0 feet; thence South parallel with said West line 350.0 feet; thence West parallel with said North line 400.0 feet; thence North parallel with said West line 10.0 feet thence West parallel with said North line 130.0 feet; thence North parallel with said West line 350.0 feet; thence East parallel with said North line 130.0 feet to the point of beginning.

SECTION 3. The Village Clerk is hereby directed to file certified copies of this ordinance in the office of the Minnesota Municipal Commission, The Carver County Auditor, and the Secretary of State of the State of Minnesota.

SECTION 4. Annexation shall be complete from and after the date when certified copies of this ordinance have been filed as directed in Section 3.
