ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MANKATO TO INCLUDE CERTAIN UNPLATTED LANDS NOT EXCEEDING TWO HUNDRED ACRES, PURSUANT TO M.S.A. SECTION 414.03, SUBDIVISION 2, AND ALL LAWS AMENDATORY AND SUPPLEMENTARY THERETO, AND IN ACCORDANCE WITH THE RULES OF PROCEDURE OF THE MUNICIPAL COMMISSION.

The City of Mankato, Minnesota, does ordain:

I.

A Petition has been filed with the City Clerk of the City of Mankato, Minnesota, by O. P. Confer and R. J. Lloyd, of the County of Blue Earth and State of Minnesota, as owners of the following described real estate, to have such lands included in the City of Mankato, Blue Earth County, Minnesota, to-wit:

Beginning at the Northeast corner, East one-half, Northwest Quarter, Section 30, Township 108 North, Range 26 West; thence South, along the East line of said East one-half, Northwest Quarter, 782.00 feet; thence West, 295.00 feet; thence North 51 degrees 00 minutes West, 380.00 feet; thence West, 590.10 feet; thence South 00 degrees 13 minutes East, 190.00 feet; thence West, 60.00 feet to a point 82.50 feet East of the West line of said East one-half Northwest Quarter; thence North 00 degrees 13 minutes West, parallel to the West line of said East one-half, Northwest Quarter, 706.15 feet to the North line of said Section 30; thence North 88 degrees 47 minutes East, along said North line of Section 30, 1242.34 feet to the point of beginning. The City Council of Mankato, Minnesota, hereby determines that the annexation of the above described property will be to the best interests of the municipality and of the land affected and that the above described tracts or parcels of land are so conditioned as properly to be subjected to city government and are hereby annexed to and declared to be an addition to the City of Mankato, as effectually as if it had originally been a part thereof and the corporate limits of the City of Mankato, Minnesota are hereby extended to include said property.

The City Clerk is hereby directed to file certified copy of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State, and this ordinance takes effect ten (10) days after its passage and publication and upon the filing of certified copies, as herein described.
