
Dear Mr. Schroeder:

ORDINANCE NO. 27

WHEREAS, James W. Downey and Lucille K. Downey have filed petitions for incorporation of the boundaries described territory to the Village of Watkins and to extend the boundary lines to include the corner and

WHEREAS, copies of said petitions have been filed with the County of Ancker, and the Township of Forest Prairie, Ancker County, Minnesota, as well as with the Minnesota Municipal Commission as required by law and

WHEREAS, more than thirty (30) days have expired since the filing of the last of said petitions and no objections thereto having been filed with the Minnesota Municipal Commission by the Village of Watkins, the said Township of Forest Prairie, and the said County of Ancker; and

WHEREAS, the territory to be annexed consists of unplatted land of less than two hundred (200) acres and is, or is about to become situate in character and shape upon the separate limits of the Village of Watkins on the northerly boundary thereof, and none of it is presently included within the corporate limits of any incorporated city, village or township

NOW THEREFORE, be it ordained by the Council of the Village of Watkins, as follows:

1. That all of the following described lands and premises

part of the West Half of the Northwest Quarter (NW¹/₄) of NE¹/₂ of Section Two (2), Township One Hundred Twenty-one North (121-N), Range Thirty, West (20-W) beginning at a point on the east line of said West Half of the Northwest Quarter (NW¹/₄) of NE¹/₂ a distance of 692.0 feet south of the Southeast corner of said West Half of the Northwest Quarter (NW¹/₄) of NE¹/₂, thence west as the north line of Block Five (5), Auditor's Report of the Village of Watkins a distance of 513.0 feet, thence North and parallel to the east line of said West Half of the Northwest Quarter (NW¹/₄) of NE¹/₂ a distance of 350.0 feet, thence East and parallel with the North line of said Block a distance of 513.0 feet, thence South on the East line of said West Half of the Northwest Quarter (NW¹/₄) of NE¹/₂ a distance of 350.0 feet to the point of beginning.

be and the same is hereby annexed to the Village of Watkins and that the separate boundary lines be extended to include the same within the corporate limits of the Village of Watkins.

2. This Ordinance shall be effective upon adoption.
