CORPORATE NO. 27

WHEREAS, James W. Crowley and Rosella K. Crowley have filed petition to
incorporate the hereinabove described territory to the Village of Webster and to amend the
boundary thereof to include the same; and

WHEREAS, copies of said petition have been filed with the County of Dakota, and
the Township of Forest Prairie, Dakota County, Minnesota, as well as with the Dakota
Municipal Commissioner, as required, by law; and

WHEREAS, more than thirty (30) days have elapsed since the filing of the last
and petition and no objections thereto have been filed with the Minnesota Municipal
Commissioner by the Village of Webster, the said Township of Forest Prairie, and the said County
of Dakota; and

WHEREAS, the territory to be annexed consists of isolated land of less than two
hundred (200) acres and is, or is about to become, urban in character and situated upon the
incorporated limits of the Village of Webster, on the territory boundary thereof, and more or less
nearly situated within the corporate limits of any incorporated city, village or town;

NOW THEREFORE, be it ordained by the Council of the Village of Webster, as
follows:

1. That all of the following described lands and premises
out of the New Half of the Northwest Quarter (1/4 of 1/4) of Section Two (2)
in the One Hundred Thirty-ninth Range North (139th Range North), Dakota
County, Minnesota, lying on the east line of said West Half of the Northwest Quarter
(1/4 of 1/4) of 1/4, the same being, as the west line of said West
Half (1/4 of 1/4), the same west as the west line of said West
Half of the Village of Webster a distance of 313.0 feet, thence North
and parallel to the east line of said West Half of the Northwest Quarter (1/4 of
1/4) a distance of 313.0 feet, thence East and parallel with the North line of
said West Half a distance of 313.0 feet, thence South on the East line of said West
Half of the Northwest Quarter (1/4 of 1/4) a distance of 313.0 feet to the point
of beginning.

be and the same is hereby annexed to the Village of Webster and that the corporate boundaries
shall be extended to include the same within the corporate limits of the Village of Webster.

2. This Ordinance shall be effective upon adoption.
