
Dear Mr. Stevens:

ORDINANCE NO. 85, NEW SERIES

AN ORDINANCE ANNEXING CERTAIN LAND TO THE CITY OF LUVERNE,  
MINNESOTA, AND EXTENDING THE CORPORATE LIMITS OF SAID CITY  
ACCORDINGLY

PREAMBLE

WHEREAS, on May 10, 1966, a Petition For Annexation signed  
by all the owners was filed with the City Council for annexation  
of certain land abutting the south boundary of the City of Luverne,  
which land is situated in the Town of Luverne, County of Rock,  
State of Minnesota and hereinafter described,

WHEREAS, Notice of Filing said Petition For Annexation was  
duly served upon the Minnesota Municipal Commission, County Board  
of the County of Rock, and Town Board of the Town of Luverne on  
the 31st day of May, 1966, and no objection has been raised, and,

WHEREAS, said land is unplatted, unincorporated and does not  
exceed 200 acres; NOW, THEREFORE,

THE CITY OF LUVERNE DOES ORDAIN:

I.

That it would be in the best interest of the City of Luverne  
to annex the land described in said Petition For Annexation, which  
land is situated in the County of Rock and State of Minnesota and  
described as follows, to-wit:

A tract of land in the Northeast Quarter (NE $\frac{1}{4}$ ) of  
Section Fifteen (15), Township One Hundred Two (102)  
North, Range Forty-five (45) West of the 5th P. M.,  
County of Rock, State of Minnesota, described as fol-  
lows: Beginning at a point on the East line of said  
Section 15, distant 1169.10 feet North of the East  
Quarter corner thereof, thence westerly at an angle  
of 90°02' with said East Section line (measured from  
North to West) for 1010.00 feet, thence deflect Nor-  
therly at an angle of 90°02' (measured from west to  
North) for 80.00 feet, thence deflect Easterly at an  
angle of 89°58' (measured from North to East) for  
160.00 feet, thence deflect Northerly at an angle of  
89°58' (measured from East to North) and running thence

parallel to said East Section line to the North line of said Section 15, thence Easterly on said North section line for 550.00 feet to the Northeast corner of said Section 15, thence Southerly on said East Section line to the true point of beginning, containing an area of 19.7 acres more or less.

II.

That the above described land should be, and is hereby, annexed to the City of Luverne, Minnesota, and the corporate limits are extended accordingly.

III.

That the effective date of this ordinance is August 12th, 1966.

Introduced to the City Council on the 12th day of July, 1966, and adopted on the 18th day of July, 1966.




