PREAMBLE

WHEREAS, on May 10, 1966, a Petition For Annexation signed by all the owners was filed with the City Council for annexation of certain land abutting the south boundary of the City of Luverne, which land is situated in the Town of Luverne, County of Rock, State of Minnesota and hereinafter described,
