
Dear Mr. Aamodt:

ORDINANCE NO. 1804

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ALBERT LEA TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ADJUTING UPON THE CITY LIMITS

Introduced by Councilman W. J. Bishop

WHEREAS, a certain petition dated June 13, 1966, requesting annexation of the territory hereinafter described was duly presented to the Council on June 13, 1966; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 7.69 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all owners and

WHEREAS, no objections to the annexation have been received from the Townboard, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the southern City Limits.

THE COUNCIL OF THE CITY OF ALBERT LEA, MINNESOTA ORDAINS:

Sec. 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected (2) that the territory described herein abuts upon the City Limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Sec. 2. Territory Annexed: The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

Beginning 767.5 feet south of the northeast corner of the northwest quarter of Section 21 - T102N - R 21W; thence 416.5 feet west; thence south 499 feet more or less to a westerly extension of the centerline of 13th Street; thence 416.5 feet east along said extended centerline of 13th Street to the east line of the northwest quarter of said section; thence 499.2 feet north along said east line of said 1/4 section to the point of beginning; subject to roadway easement on the east 16.5 feet and the south 33 feet thereof.

And

Beginning 367.5 feet south of the northeast corner of the northwest quarter of Section 21, Township 102 North, Range 21 West; thence 637 feet west; thence 200 feet south; thence 637 feet east; thence 200 feet north to the point of beginning; containing 2.923 acres; and being part of the northeast quarter of the northwest quarter of Section 21, Township 102 North, Range 21 West; subject to roadway easement on the easterly 16.5 feet thereof.

Sec. 3. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Sec. 4. That the above parcel first listed be designated as H-2 Heavy Industrial District and that the second parcel above listed be designated as C-2 - General Commercial District.

Sec. 5. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
