

I, LEONARD A. JOHNSON, City Clerk of the City of Minneapolis in the County of Hennepin and State of Minnesota, do hereby certify that proposed Amendment No. 20 to the City Charter of the City of Minneapolis, of which the attached is a true and correct copy, was submitted to the electorate at a Special Election held at the same time as the State Primary Election on Tuesday, September 13, 1966; that notice of said Special Election and the proposed Amendment No. 20 to the City Charter were duly published, all pursuant to the Statutes of the State of Minnesota and the action of the City Council of the City of Minneapolis on July 29, 1966; that at the said Special Election held as above stated, there were 59,326 votes cast on the question; that the number of votes cast in favor of said proposed amendment was 39,608; that the number of votes cast against the said proposed amendment was 19,718; that the number of votes necessary for the adoption of said proposed amendment was 55 per cent, or 32,629; that said proposed Amendment No. 20 was duly adopted by the qualified votes of the City of Minneapolis and therefore becomes Amendment No. 20 to the City Charter of the City of Minneapolis.

"Provided, that the aggregate or annual levy of such taxes shall never exceed in any one year six (6) mills on the dollar upon the assessed valuation of said city."
