ORDINANCE NO. 1966.

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF ALBANY TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LANDS, WHICH LAND IS SURVEYED FIVE PERCENT OR MORE BOUNDARY ON THREE SIDES BY THE VILLAGE OF ALBANY.

WHEREAS, certain property described below is not presently included within the corporate limits of any incorporated city, village, or borough;

WHEREAS, this territory is 75% or more bounded on three sides by the corporate limits of the Village of Albany, and is deemed to be urban in character; and

WHEREAS, notice of intent to annex said lands to the Village of Albany was served upon the officers of the Township of Albany on the 13th day of April, 1966 and no objection to said annexation has been filed with the Village of Albany nor with the Municipal Commission.

The Village Council of the Village of Albany, Minnesota ordains:

Section 1. **TERRITORIAL EXTENSION.** The corporate limits of the Village of Albany, Minnesota, are hereby extended to include the unplatted territory described as follows, which territory is 75% or more bounded on three sides by the Village of Albany:

The westerly three hundred five (305) feet of the that part of the northeast quarter of the southeast quarter (SW 1/4) of Section 14, Township 10N, Range 20E, and being part of Township Number One Hundred Twenty Five (125) North of Range Twenty One (21) West, Stearns County, Minnesota.

Section 2. **FILING.** The Village Clerk is directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor of Stearns County, and the Minnesota Municipal Commission.

Section 3. **REVERSIVE DATE OF ANNEXATION.** This Ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.
