ORDINANCE No. 141

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF CAMBRIDGE, ISANTI COUNTY, MINNESOTA, TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA.

WHEREAS, a certain petition dated the 11th day of May, 1966, requesting annexation of the territory described below, was duly presented to the council and filed in the office of the Village Clerk on July 26, 1966; and

WHEREAS, said petition for annexation was signed by the Chairman and Clerk of the School Board of the petitioning School District, a municipal corporation, which municipal corporation is the sole owner of the said territory described below; and

WHEREAS, a true and correct copy of said petition for annexation was filed in the office of the Township Clerk of the Township of Cambridge on July 26, 1966, and in the office of the County Auditor in and for Isanti County, Minnesota on July 26, 1966, the said Township and County being the same in which all of the land to be annexed is located; and

WHEREAS, a true and correct copy of said petition for annexation, together with the required certificates of filing the same and the other required items, have been duly filed with the Minnesota Municipal Commission on or about July 26, 1966, and copies of the Certificate of Filing have been duly mailed to the Isanti County Auditor and the Minnesota Secretary of State; and

WHEREAS, the Village Council has determined that the annexation of the territory hereinafter described will be to the best interest of the municipality and of the territory affected, and that said territory is so conditioned as properly to be subjected to Village government:

NOW THEREFORE, THE VILLAGE COUNCIL OF CAMBRIDGE ORDAINS:

Section 1. Declaration. It is hereby determined that the territory described below abutts upon the Village of Cambridge and is so conditioned as to properly be subjected to Village government, and that the annexation thereof would be to the best interest of the Village of Cambridge and the territory affected.

Section 2. Territory Annexed. The corporate limits of the Village of Cambridge are hereby extended to include the territory described as follows, to-wit:

That part of the South Half of the Northeast Quarter (S% OF NE%) of Section Twenty-mine (29), Township Thirty-six (36), Range Twenty-three (23), described as follows, to-wit:
