## ORDINANCE NO. 280

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HUTCHINSON AND ANNEXING THERETO CERTAIN UNPLATTED LAND FORMERLY LOCATED IN THE TOWNSHIP OF HASSAN VALLEY (Hutchinson Industrial District)

The City Council of the City of Hutchinson ordains:

SECTION I. A petition has been filed with the governing body of the City of Hutchinson, Minnesota by Hutchinson Growth, Inc. being the sole owner of the following described real estate, to have said property annexed and included iwthin the corporate limits of the City of Hutchinson, County of McLeod, State of Minnesota, to-wit:

Lots 2, 3, 4, 5 and 6 of the Auditor's Plat of the West Half of Section 5, Township 116 North, Range 29 West.

SECTION II. The quantity of land embraced within the foregoing description, and bounded as described, is less than 200 acres.

SECTION III. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Hutchinson, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City Government.
