ORDINANCE NO. 205

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF EAST GRAND FORKS TO INCLUDE CERTAIN UNPLATTED LAND IN THE WEST HALF OF THE NORTHWEST QUARTER OF SECTION 36. TOWNSHIP 152, NORTH OF RANGE 50, WEST OF THE FIFTH PRINCIPAL MERIDIAN. POLK COUNTY, MINNESOTA, NOT EXEEDING TWO HUNDRED ACRES, WHICH TRACT CONTAINS 2.220 ACRES.

The City Council of the City of East Grand Forks, Minnesota, do ordain:

Section 1. A petition has been filed with the City Council of the City of East Grand Forks, Minnesota, by Homer L. Matheson and Margaret M. Matheson, Vernon G. Hagen and Marilyn Hagen, Thomas W. Ryan and Joan Ryan, Gerald C.
