ORDINANCE NO. A 348

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF FARIBAULT TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND MEASURING ONE HUNDRED ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition requesting annexation of the property hereinafter described was duly presented to the council on the 6th day of July, 1966; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 143 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all ten of the owners of said land; and

WHEREAS, no objections to the annexation have been received from the town board, the county board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the south boundary thereof,

The Council of the City of Faribault do ordain:

Sect. 1. DETERMINATION OF NEED. The City Council hereby determines

- (1) what incorporation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. TERRITORY ANNEXED. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectively as if it had originally been a part thereof:

the North One-half (N $\frac{1}{2}$) of Southeast Quarter (SE $\frac{1}{4}$) except the first Two Hundred Fifty-nine (259) feet of the North Forty - eight Ninety-eight (48 $\frac{1}{2}$) feet of the South Forty - eight Ninety-eight (48 $\frac{1}{2}$) feet of the South One-half (S $\frac{1}{2}$) of the Southwest Quarter (SW $\frac{1}{4}$) lying North of the line of any of the C. & N. Co., Milwaukee and St. Paul Railway Company; and that part of the North One-half (N $\frac{1}{2}$) of the Southwest Quarter (SW $\frac{1}{4}$) lying East

of Minnesota Trunk Highway No. 65; all that part of the North One-half ($\frac{1}{2}$) of the Southeast Quarter (SE $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) lying East of the main line of the right-of-way of the Chicago, Milwaukee and St. Paul Railway Company, all of said above described tract being located in Section One (1), Township One Hundred Nine (109) North of Range Twenty-one (21) West in the said County of Rice and State of Minnesota.

Section 3. FILING. The City Recorder is hereby directed to file certified copies of this ordinance with the Municipal Commission, the Secretary of State and the County Auditor.

Section 4. EFFECTIVE DATE. This ordinance shall take effect ten days after its passage and publication but in no event until the filing of certified copies as directed in Section 3 above.
