



ORDINANCE NO. 399

AN ORDINANCE DETERMINING THE CORPORATE LIMITS OF THE CITY OF WORCESTER, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED LANDS.

The City Council of the City of Worthington Do Ordain:

Section 1. A petition has been filed with the City Council of the City of Worthington, Minnesota, signed by all of the owners in number of the following described real estate, to have such land included within the City of Worthington, Minnesota:

That part of the West Half (W $\frac{1}{2}$) of Section 22, Township 102 North, Range 10 West, described as follows: Beginning at the center of said Section 22; thence North 00°00' East on the East Line of the Northwest Quarter of said Section 22 for 165.60 feet; thence North 89°36' West for 1325.00 feet to the sixteenth line; thence South 00°00' East for 165.60 feet to the North line of the Southwest Quarter of said Section 22; thence North 89°36' West on said North line of Southwest Quarter for 1325.00 feet to the West Quarter corner of said Section 22; thence South 00°00' East on the West line of said Section for 1175.40 feet; thence South 75°00' East for 900.00 feet to the North line of the right-of-way of County Highway No. 19; thence North 61°25' East to the westerly line of Hobie Avenue; thence North 18°27' West along the westerly line of Hobie Avenue to the northerly line of Parker Subdivision; thence Northeasterly along the North line of said Parker Subdivision and which line is parallel to the formerly known County Highway now known as West Lake Avenue, to the westerly line of Thompson Avenue in Parker Subdivision; thence Northerly along the westerly line of Thompson Avenue for 32 feet; thence Easterly at 90° for 220 feet to the easterly line of the Southwest Quarter of said Section 22; thence Northerly along the North line of said Section for 1051.27 feet to the point of beginning; all being in Nobles County, Minnesota.

Section 2. The quantity of land embraced within the foregoing description, and bounded and described is 64 acres.

Section 3. Notice was duly given the Board of Commissioners for Nobles County and the Board of Commissioners for Worthington Township on September 19, 1966, that said petition was being considered by the City Council of the City of Worthington and a hearing was duly held by the City Council of the City of Worthington, on the proposed annexation after publication of notice of hearing as required by City Charter.

Section 4. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Worthington, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.

Section 5. The corporate limits of the city are hereby extended to include the property described in Section 1, and the same is hereby annexed to, and included in the City as effectually as if it had originally been a part thereof.

Page 2 -- Ordinance No. 399

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

Section 7. This ordinance shall take effect upon its passage and publication and upon the filing of the certified copies as directed in Section 6.
