CERTIFICATE NO. 100

AN ORDINANCE EXTINGUISHING THE CONTROVERSY LINES OF THE CITY OF WORTHINGTON, MINNESOTA, TO INCLUDE CERTAIN UNPLATTED LINES.

The City Council of the City of Worthington Do Ordain:

Section 1. A petition has been filed with the City Council of the City of Worthington, Minnesota, signed by all of the owners in number of the following described real estate, to have such land included within the City of Worthington, Minnesota:

A tract of land in the Southwest Quarter (SW $\frac{1}{4}$) of Section Thirteen (13), Township One Hundred Two (102), Range Forty (40), Nobles County, Minnesota, described and bounded as follows:

Commencing at the Southwest corner of said SW $\frac{1}{4}$, thence running North on the West line of said SW $\frac{1}{4}$ a distance of 1287 feet to the point of beginning, thence East and parallel with the South line of said SW $\frac{1}{4}$ a distance of 300 feet, thence North and parallel with the West line of said SW $\frac{1}{4}$ to the North line of said SW $\frac{1}{4}$, thence West along the North line of said SW $\frac{1}{4}$ to the West line of said SW $\frac{1}{4}$, thence South along the West line of said SW $\frac{1}{4}$ to the point of beginning,

and

A tract of land in the Northwest Quarter (NW $\frac{1}{4}$) of Section Thirteen (13), Township One Hundred Two (102), Range Forty (40), Nobles County, Minnesota, described and bounded as follows:

Commencing at the Southwest corner of said NW $\frac{1}{4}$, thence East along the South line of said NW $\frac{1}{4}$ a distance of 300 feet, thence North and parallel with the West line of said NW $\frac{1}{4}$ a distance of 500 feet, thence West and parallel with the South line of said NW $\frac{1}{4}$ to the West line of said NW $\frac{1}{4}$, thence South on said West line of said NW $\frac{1}{4}$ to the point of beginning,

and

A tract of land in the Southeast Quarter (SE $\frac{1}{4}$) of Section Thirteen (13), Township One Hundred Two (102), Range Forty (40), Nobles County, Minnesota, described and bounded as follows:

Commencing at the Southeast corner of said SE $\frac{1}{4}$, thence North along the East line of said SE $\frac{1}{4}$ a distance of 204.3 feet to the point of beginning, thence West and parallel with the South line of said SE $\frac{1}{4}$ a distance of 300 feet, thence North and parallel with the East line of said SE $\frac{1}{4}$ to the North line of said SE $\frac{1}{4}$, thence East and along the North line of said SE $\frac{1}{4}$ to the East line of said SE $\frac{1}{4}$, thence South along the East line of said SE $\frac{1}{4}$ to the point of beginning.

Section 2. The quantity of land embraced within the foregoing description, and bounded and described is 30.8 acres.

Section 3. Notice was duly given the Board of Commissioners for Nobles County and the Board of Commissioners for Worthington Township on September 19, 1966, that said petition was being considered by the City Council of the City of Worthington and a hearing was duly held by the City Council of the City of Worthington, on the proposed annexation after publication of notice of hearing as required by City Charter.

Page 2 --- Occurrence No. 100

Section I. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Worthington, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.

Section 5. The corporate limits of the city are hereby extended to include the property described in Section 1, and the same is hereby annexed to, and included in the City as effectually as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

Section 7. This ordinance shall take effect upon its passage and publication and upon the filing of the certified copies as directed in Section 6.
