IN THE MATTER OF THE RESOLUTIONS OF THE CITY OF HOPKINS AND THE
VILLAGE OF MINNETONKA FOR THE SIMULTANEOUS ANNEXATION AND DETACHMENT
OF CERTAIN PROPERTY UNDER M.S.A. 414.06.

O R D E R

The Village of Minnetonka has, by resolution of the village council dated November 7, 1966, petitioned for the detachment of certain property and the City of Hopkins has concurrently, by resolution of the city council at a regular meeting held on October 18, 1966, petitioned to annex the same territory, pursuant to M.S. 414.06.

The territory involved consists of:

That part of the SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Sec. 23, T117, Range 22, described as follows: Commencing at a point in a line parallel to and 660 feet West at right angles from the east line of said subdivision which point is 689.3 feet measured along said line northerly from the intersection of said line with the northerly line of the right of way of the Chicago-Milwaukee and St. Paul Railroad Company, thence West at right angles 291 feet to the point of beginning of the tract to be described; thence continuing West 362.6 feet more or less to the West line of said subdivision, thence north to the northwest corner of said subdivision; thence east along the north line thereof to an intersection with a line drawn from the actual point of beginning, parallel with the east line of said subdivision thence South along said parallel line to the point of beginning.

That part of the SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Sec. 23, T117, Range 22, described as follows: Commencing at a point in a line parallel to and 660 feet West at right angles from the East line of said subdivision which point is 689.3 feet measured along said line Northerly from the intersection of said line with the northerly line of the right of way of the Chicago, Milwaukee and St. Paul Railroad Company, thence West at right angles 291 feet; thence North at right angles, to the North line of said subdivision; thence East along the North line of said subdivision to a point in a line parallel to and 660 feet West at right angles from the East line of said subdivision; thence southerly on an extension of the last mentioned line to the point of beginning.

All the requirements of the statutes having been met,

IT IS ORDERED: That the above described property be and same hereby is detached from the Village of Minnetonka and annexed to the City of Hopkins, the same as if it had originally been a part thereof.
