
Dear Mr. Myhre:

ORDINANCE NO. 27

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WARREN TO INCLUDE CERTAIN UNFLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES.

Section 1. A petition has been filed with the governing body of the City of Warren, Minnesota, by the sole owners of the following described real estate to have such land included within the City of Warren, Minnesota:

Commencing at the northwest corner of Section Six (6), Township One Hundred Fifty-four (154) North of Range Forty-seven (47) West; thence due south along the west section line of Section 6 for a distance of 75 feet to the true point of beginning; thence easterly along a line parallel to the north section line of Section Six (6) for a distance of 590 feet; thence southerly along a line parallel to the west section line of Section 6 to the intersection of St. Paul, Minneapolis and Sault Ste. Marie right-of-way, a distance of 1,006.15 feet; thence westerly along the railway right-of-way in a one degree curve to an existing concrete monument at the intersections of the railroad right-of-way and the west section line of Section 6, an approximate distance of 596 feet; thence northerly along the west section line of Section 6 for a distance of 1,035.31 feet to the point of beginning.

Section 2. The quantity of land embraced with the foregoing description, and bounded as described, is 14.17 acres.

Section 3. The City Council hereby determines that the annexation will be to the best interests of the City of Warren, Minnesota, and of the territory affected and that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

Section 4. Therefore, the City of Warren, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of Warren, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
