
Dear Mr. Flora:

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE  
OF LONG PRAIRIE TO INCLUDE CERTAIN UNINCORPORATED, PLATTED  
LAND ADJUTING UPON THE VILLAGE LIMITS.

WHEREAS, a certain petition, dated September 30, 1966, requesting  
annexation of the territory hereinafter described was duly presented to the Council  
on the 3rd day of October, 1966, and

WHEREAS, the quantity of land embraced within the area described in  
the petition and bounded as described is less than two hundred (200) acres of platted  
land, no part of which is included within the limits of an incorporated city, village  
or borough, and

WHEREAS, the petition was signed by all of the owners of said land, and

WHEREAS, no objections to the annexation have been received from the  
town board, the county board, or the governing body of any municipality whose  
boundaries abut upon the lands to be annexed, and

WHEREAS, a copy of said petition was filed with the Municipal Commission  
of the State of Minnesota, the County Auditor of Todd County, and the Town Clerk of  
Long Prairie Township, on October 7, 1966, and

WHEREAS, the land described in the petition abuts upon the Village limits  
at the south boundary thereof;

The Council of the Village of Long Prairie, Minnesota, ordains:

Section 1. The Village Council hereby determines:

- (a) That the annexation will be to the best interests of the Village, and  
of the territory affected.
- (b) That the territory described herein abuts upon the Village limits  
and is urban or suburban in character.
- (c) That none of the territories are now included within the limits of  
any city, village or borough.

Section 2. Territory Annexed. The corporate limits of the Village are hereby extended to include the platted land described as follows, and the same is hereby annexed to and included in the Village as effectually as if it had originally been a part thereof:

Lots One (1), Two (2) and Three (3) Fortmann's Subdivision, and that part of Sixth Street Southeast abutting thereon.  
Lots Seven (7) through fifteen (15), Block One (1) Lakeside Addition to the Village of Long Prairie, together with that part of Fourth Street South abutting thereon, and that part of the public alley abutting thereon and located to the west thereof.

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3.
